- Call to order President Evan called the meeting to order at 6:50 pm.
- 2. Speaker of the House Barbara Snyderman was appointed the Speaker of the House and took the gavel from the President to begin the meeting.
- 3. Credentials There were 15 delegates, 8 which represent a majority.
- 4. Approval of Agenda

MOTION 1: Moved by Chase, seconded by Hunt that the ASCLS-PA House of Delegates approve the agenda as presented. Motion passed.

- 5. Approval of Minutes of 2012 House of Delegates
 - MOTION 2: Moved by Franz, seconded by Lachance that the ASCLS-PA House of Delegates approve the minutes of the 2012 ASCLS-PA House of Delegates as presented. Motion passed.
- 6. President's Report President Evans presented a verbal report. Highlights included a successful student forum review session, an overhaul of the web site, a winter newsletter and the spring meeting in Harrisburg.
- 7. Region II Director Report Barbara Snyderman presented a verbal report. Highlights included:
 - a. A Region II conference call every other month, with poor attendance
 - b. Sherry Miner will be retiring from ASCLS in September
 - c. The ASCLS National Meeting will be held in Houston in July
- 8. Committee Reports:
 - a. Awards A written report was received from Chair Mary Gourley. The 20 year and sustaining membership awards still need to be given.

b. Bylaws – A bylaws and SOP change was submitted for approval by the House of Delegates

MOTION #3: Moved by Lachance, seconded by Evans that the ASCLS-PA House of Delegates accept the Bylaws change as presented. Motion Passed unanimously.

Article XIII.B and Article XIII.C to now read:

B. The total number of delegates is exclusive of the officers and members of the Board of Directors of ASCLS having residence in this State in attendance at the Annual Meeting.

C. The selection of delegates shall be defined in the Standard Operating Procedures of this Society.

MOTION #4: Moved by Hunt, seconded by DeJoie that the ASCLS-PA House of Delegates accept the SOP changes as presented. Motion Passed.

Article XIII A, B, and C to now read:

A. Each Society is entitled to the following delegates: Society President, President-Elect, Student Representative, New Professional, and a total number of delegates-at-large as determined by ASCLS.

B. Delegates-at-large shall be elected at the Annual Meeting of the ASCLS-PA House of

Delegates

- C. One New Professional delegate to the ASCLS House of Delegates shall be elected by the ASCLS-PA House of Delegates. In the event a NP delegate is not elected or cannot attend the ASCLS Annual Meeting, the President shall appoint a New Professional as a delegate. If no NP delegate is elected or appointed, the position shall remain vacant.
- D. All subsequent sections of Article XIII to be renumbered.

- finance The Finance chair presented the results of the Audit for the year ending 8/31/12. No issues were noted during the audit.

MOTION #6: Moved by Hunt, seconded by Lachance to elect by acclamation the following slate of candidates: Laura Taraborrelli, Presdient; Michael Osbourne. President-Elect; Katie Franz and Michael Lachance, Board of Directors; Scott Aikey, Treasurer. Motion Passed.

10. Treasurer's Report: Sharon Strauss presented her report. There was \$103.34 in interest from FY12 not reported in FY13 for the Operating Funds and \$32.82 in the Scholarship Funds.

MOTION #7: Moved by Aikey, seconded by DeJoie that the ASCLS-PA House of Delegates accept the Treasurer's report dated 4/30/13 for the Operating Funds and file for audit. Motion Passed.

MOTION #8: Moved by Aikey, seconded by Evans that the ASCLS-PA House of Delegates accept the Treasurer's report dated 4/30/13 for the Scholarship Funds and file for audit. Motion Passed.

MOTION #11: Moved by Taraborrelli, seconded by Lachance that the ASCLS-PA House of Delegates allocated delegates funds equally amongst the final number of delegates going to Houston.

 FY 14 Budget - Treasurer Sharon Strauss presented the ASCLS-PA Fiscal Year 2013-2014 budget.

MOTION #12: Moved by Aikey, seconded by Hunt that \$2500 be taken from the Contingency Fund and moved to the proposed FY14 budget. Motion Passed.

MOTION #13: Moved by Franz, seconded by Hunt that the FY14 proposed budget be adopted as presented. Motion Passed.

d. Governance:

MOTION #14: Moved by Hunt, seconded by Aikey that the ASCLS-PA President appoint a Task Force to recommend changes to the structure of the ASCLS-PA House of Delegates. Motion Passed.
