I also urge you to participate in the Annual Business Meeting (ABM) the day before on Sunday May 15th at 3pm. Registration to the Spring Meeting isn't necessary to attend, and if you can't make it in person, please keep an eye on your email for information about joining

As our primary grassroots governing body, the ABM allows any Professional, Ascending, or Emeritus member of the ASCLS-PA to voice their opinion and vote on matters concerning the state society, such as election of officers and changes to the bylaws. Up for grabs this year are the positions of President, President-Elect, Secretary, and Board Member. Jf you're an Ascending or Developing Professional interested in seeing how the Board operates, let me know (at travisbicher@gmail. com) and I'll pass this along to the incoming President, who makes that selection.

If you're looking to travel somewhere slightly more glamorous for your medical laboratory professional needs, then check out the Joint Annual Meeting (JAM) on June 26th to 30th in Grand Rapids, Michigan. There will be CE presentations, research posters from those in the lab, a Demo Pavilion for industry engagement, and plenty of events to socialize and network with your fellow laboratorians.

the governing body of the ASCLS. The organization has continued to increase engagement with membership by holding the HOD twice yearly, and I attended the meeting on January 16th.

One of the primary topics currently on the table is a change in the structure of ASCLS's governance. Presently, the state constituent societies are grouped into 10 regions, and each has to have a Director on the Board. ASCLS is moving to have instead 10 at-large Directors from anywhere in the nation.

There are two main reasons for this, one being that the regions are not equal in terms of either share of the membership nor number of lab professionals nationwide, and a few regions over-represent, having a percentage of members greater than their percentage of professionals (see the marked map). This isn't necessarily a bad thing, but it could be skewing the perspectives and decisions of the Board. The second is that with the change, a Director's responsibility will be not to their own constituent states but to the organization as a whole, allowing them to better uphold the typical non-profit fiduciary duties of care, loyalty, and obedience. It was suggested that there be minimum requirements and testing competency as part of the nomination process.

The Board of Directors is asking for feedback on how to keep constituent societies and national connected with this change, but they feel that the representative nature of the House of Delegates and the direct communication afforded by the online, freely accessible Connect Communities allow states to have their say. ASCLS wants to offer opportunity to its members, not a waiting list, and hierarchy can get in the way of that.

All that said, a solid plan beyond removing the region requirement was not presented. I'll be representing PA at the next HOD, so please let me know your thoughts

on this situation.

Regarding the PAMA cuts I discussed in my last message, CMS has issued statements indicating that it doesn't intend to verify data received from laboratories on Medicare payments for lab testing, which continues to be heavily weighted in the favor of large independent laboratories that spend less per test and have the resources to meet reporting requirements (they're 91.5% of the data received!). A June 2021 report from MedPAC recommended sampling random laboratories to get more accurate results and reduce the burden of reporting on smaller labs.

On the front of improved regulation and oversight of lab-developed tests, there are two competing proposals in Congress: the Verifying Accurate, Leading-edge IVCT Development (VALID) Act (H.R.6201/S.3404) and the Verified Innovative Testing in American Laboratories (VITAL) Act (S.3512). The ASCLS supports the VALID Act as it would create a single, diagnostics-specific regulatory framework within the FDA while modernizing oversight.

Task forces are working to update position papers on Point of Care Testing, Scope of Practice, and Healthcare Reform. Presented for review was a draft of a paper combining "Practice Levels and Educational Needs for Clinical Laboratory Personnel" and "Model Career Ladder". The Levels of Practice Model has guidelines for 7 ascending categories of job responsibilities, listing technical skills that each level is expected to perform in the laboratory, starting at phlebotomy and going up to grant-funded research and clinical assessment, linked to an appropriate required level of education, certification, and previous experience.

It is suggested that this be used in combination with the Model Career Ladder, which focuses on professional

Bylaws

Mary M. Gourley ASCLS-PA Awards Chair

Delegates to the 2022 ASCLS House of Delegates will be voting on amendments to the ASCLS Bylaws, Article IV – Board of Directors, Article IX – Regional Councils, and Article X – Society Forums.

The amendments are:

Amendment #1:

Article IV - Board of Directors

B. Composition

The number of voting directors shall be sixteen (16) – the President, President-elect, Secretary/Treasurer, Past President, and ten (10) Regional Directors elected by the House of Delegates in a manner prescribed by the Board of Directors of the Society. There shall be one (1) voting Developing Professional Director elected by the Developing Professional Forum of the Society and one (1) Ascending Professional Director.

Article IX - Regional Councils

- A. Regional Councils

 There shall be at least ten (10) Regional
 Councils composed of constituent societies.
- B. Functions

The Regional Council shall function to coordinate within geographical boundaries activities, which support the principles and further the goals of the Society, and to provide for the constituent societies of a region greater access to and utilization of the resources of the Society.

Composition
 A Regional Council shall consist of officers of constituent societies as defined in regional guidelines.

Amendment #2:

Add Section D to Article X – Society Forums

- D. Clinical Laboratory Educators Forum
 - The Clinical Laboratory Educators
 Forum shall engage and facilitate the
 involvement and interest of Clinical
 Laboratory Educator members in this
 Society.
 - The Clinical Laboratory Educators
 Forum shall be governed by guidelines, which shall be approved by the Board of Directors.
