Hello ASCLS-PA members! It has occurred to me that I never had a chance to properly introduce myself to all of you. I'm Stephanie and I'm the president of ASCLS-PA for the 2022-2023 society year. I've been a member of ASCLS-PA since I was a student, which I can't believe was 10 years ago. While completing my clinicals at Pennsylvania hospital, I was the student representative for ASCLS-PA. This position allowed me to meet so many mentors on the state and national level and made me excited about joining this profession. It is the people I've met in ASCLS that have made my membership so valuable and keep me renewing year after year.

My involvement in ASCLS is also partially responsible for the sharp turn my career path took. As a new professional I became involved in the ASCLS government affairs committee. Through this committee, I learned all about the legislation and regulation that affects the clinical laboratory, such as laboratory reimbursement and how that affects testing availability and staffing. It became clear to me that a lot of the laws and regulations affecting the clinical laboratory did not always have the desired effect or actually ended up causing negative effects to the laboratory and ultimately our patients. I realized that this was happening because the people making these laws and policies did not understand the clinical laboratory. I thought about how things would be different if legislators or regulators had an under-

standing of the clinical laboratory, and then figured "why not me?" I figured that I could be the change that I was looking for.

In May 2017, I took a huge leap of faith and left my job as a medical laboratory scientist to start law school. Law school was one of the scariest and most challenging things I've ever done, but every step of the way I was supported by my ASCLS family. I graduated with my JD in 2019 with a concentration in health law and got a job working as a legislative attorney for a non-profit policy organization that focuses on drug policy. My medical laboratory background allows me to bring a unique perspective to my work and approach problems from a scientific viewpoint. My career path has led me down an unexpected road, but I love where I have ended up.

Being an ASCLS member has shown me that the opportunities are endless when it comes to a medical laboratory background. You can do anything you put your mind to and a degree in the medical laboratory field is just the start. You can springboard into management, education, public health, research, industry, and even law! Both ASCLS-PA and national are always looking for volunteers for officers, committees, and taskforces. Remembering Patsy Bering

ASCLS-PA leadership members were notified in December of the passing of ASCLS Past President Nellie Mae "Patsy" Bering at the age of 93.

Patsy was a valued member of ASCLS and our state society. She was the oldest living past president of ASCLS and the youngest ever elected at age 31.

Elected President-elect in 1959 of what was then ASMT, Patsy told us the story of arriving at the meeting where she would be elected. She drove to the meeting in Texas in a convertible with two close friends, the late Anna Fagelson and Roma Brown. The car had no air conditioning. She recalled that they arrived at the hotel windblown and slightly sunburned and looking nothing like a candidate for PE. At the same time they pulled up to the hotel, the opposing candidate arrived looking as if she had just stepped out of a salon and dressed to the nines.

Patsy was a dedicated medical laboratory scientist. She worked for Temple University educating future MLSs

until her retirement. She continued to serve ASCLS-PA as scholarship chair for many years and attended as many meetings as she was able. Her last national meeting was at the Alpha Mu Tau Fraternity dinner in Philadelphia in 2016.

She was living independently until just two years before her passing at which time she had assistance in her home. Patsy enjoyed politics and being surrounded by walls of books in her office. ASCLS-PA members celebrated her 90 th birthday with her and she announced that she had bought herself a brand new vehicle—her first new one in over 20 years. Sadly, she gave up driving a few months later.

ASCLS Mid-Year HOD 2022-2023

The 2022-2023 Mid-Year ASCLS House of Delegates was convened on Sunday, January 15, 2023 at 1:00 PM ET to discuss business of the society. The discussion primarily served to frame and shape discussions and plans for committees and boards to make changes and plan moves in upcoming meetings and for vote by the 2023-2024 HOD at the 2023 Joint Annual Meeting in Providence, RI.

The Position paper task force had two items for review. One of which is the draft Patient Safety and clinical Laboratory Science Position Paper which will be voted on for adoption at the next HOD meeting. The previous edition of the Patient Safety and Clinical Laboratory Science position paper was adopted by ASCLS in 2015 and was updated by members of the patient safety committee. You can reach out to a member of the committee to see the drafted paper and give feedback to the committee. The second item was presented to gather delegate opinions insights and information. The ASCLS BOD recently approved a taskforce to draft a paper regarding social and economic determinates of health. They noted that it is within the laboratory professional's scope of practice and influence to make statements and changes to outdated testing methods, normal ranges, calculations, methods of collection, methods of result delivery, and access laboratory testing which have had negative impacts on particular

populations. This group proposed questions regarding need and scope for the purpose of gathering information prior to drafting a paper. The workgroup posed the following three questions to the HOD.

- 1. What is the scope of the clinical laboratory and therefore ASCLS's scope regarding specific patient populations and social, behavior, and cultural determinants of heath?
- 2. What position should ASCLS take on the medical laboratory professional's role in impacting these specific patient population and social, behavior and cultural determinants of health?
- 3. What position, either by the SODH taskforce or in a separate taskforce/position paper should ASCLS take on the role that systemic racism is a well-established factor in negative health outcomes?

As members of ASCLS, you are free to let your thoughts be heard and your voice included in this position paper. The task force will begin the work of drafting and editing the paper over the next few months and put forward a completed paper to be adopted at a future HOD. Position papers adopted by the ASCLS HOD are statements about how we, as a professional society, feel and believe regarding a particular issue related to our scope of practice and expertise. We use these position papers when

working with other professional organizations, lobbying groups, legislators, and students. It is important that your voice is heard in your society so that the position papers written and adopted by the whole reflect you and your lived experience. Executive Vice President Jim Flanigan presented a comprehensive legislative update. Nationally, December marks the end of the legislative session when large amounts of budgetary and legislative actions are pushed through congress. Often times actions that have passed through committees but were not debated on the floor of the house are wrapped into omnibus bills. Notably, Saving Access to Laboratory Services Act (SALSA) which was to be a permanent fix to the cuts brought about by PAMA did not pass. Nor did Verifying Accurate Leading Edge IVCT Development (VALID) which would require some measure of oversight for laboratory developed testing. PAMA cuts to Medicare reimbursement of laboratory testing fee schedule would have resumed January first, however, these cuts have been delayed again, and we should expect to hear and see actions being taken during the 118th congress. The Food and Drug Administration (FDA) maintains that they have always had oversight over laboratory developed tests (LDTs) and are expected to pursue formal rule-making actions regarding LDTs in the coming months. The third major area we expected some legislative movement on was supporting the laboratory workforce. The comment period for the proposed changes to CMS CLIA guidance has closed, however final rule-making has not yet been posted regarding changes to the laboratory fee schedule, and changes to qualifications for service as a high complexity laboratory director and who can perform moderate to high complexity testing. Funding has been secured however for Health Resources and Services Administration Title VII and Title VIII as well as through the CDC to provide funding for training opportunities. It is expected that a new bio preparedness bill which would also provide funding for pathways to allow more professionals to enter the field will be proposed in the 118th congress. We are also making efforts to adjust the way our profession is portrayed by the U.S. Bureau of Labor Statistics.

ASCLS members will continue to be kept up-to-date with legislative and rule-making changes through the ASCLS Connect Community Open Forum page. Be sure that you are subscribed to have postings in the Open Forum sent directly to your email so that you can keep track of how and where to get involved. You do have a role in

making your professional voice heard by those crafting laws that affect you and your practice. A great place to get started is by planning to attend the ASCLS Legislative Symposium in Washington, D.C. on October 23-24, and contribute to the Political Action Committee at the upcoming ASCLS-PA meeting or online at ASCLS.org.

Another important topic presented at the Interim HOD meeting were the findings by the Constituent Society Health Assessment. Through surveys of all ASCLS Constituent Societies, it was found that while all societies are under the ASCLS umbrella, each one is unique. Through their work, the Constituent Society Task Force found that there are opportunities for the ASCLS National office and board to develop trainings in finances, taxes, and corporate filings to aid constituent society leadership. There are also opportunities for other types of leadership development and training. Within each constituent society, there is the budget and opportunity to recruit and develop volunteers to support both the individual members' growth and the goals of the society. ASCLS-PA President Stephanie Noblit will be speaking to how ASCLS-PA compares to other constituent societies and opportunities found through the assessment at future board meetings and the ASCLS-PA annual business meeting. All ASCLS-PA members are welcome to attend. Please look for announcements for how to join these meetings in Pennsylvania State Society Connect Community. She will also be following up on the interest in exploring potential realignment of ASCLS-PA with a different region than the current regional alignment grouping ASCLS-PA with constituent societies in Washington, DC, Delaware, Virginia, West Virginia, New Jersey, and New York. There has not been any formal discussion on this topic yet, however, it was felt that it could be useful to explore other alignments which would make sense for our large and geographically spread constituent society.

The last major topic for presentation and discussion at the ASCLS HOD Interim meeting was to discuss the scope and criteria for exclusion of meeting sites. As a grassroots professional organization, it is important that our individual members ideals, values, and voices are heard and seen in how and where our society conducts business and where site venues for in-person meetings are chosen. ASCLS President Kim Von Ahsen stated:

ASCLS believes it is important to continue to have conversation in especially in areas where we recognize members may have a variety of perspectives on political, social, and cultural issues. As members, laboratory

professionals, and individuals, these issues whether experienced or unseen impact our laboratory community and diverse populations of patients we serve. We have a duty to provide a space for discussion of these issues that while it may be uncomfortable, often approached with apprehension due to potential conflict' ultimately the purpose is for respectful dialogue that leads to healthy and transparent resolution of concern or actionable work for ASCLS.

A robust conversation from delegates in attendance

continued where individuals could express concerns and desires for political neutrality, psychological and physical safety, and financial responsibility all be undertaken by the board when selecting potential meeting sites. Currently, meeting site contracts have been entered for 2023 and 2024 meetings. All members are welcome to attend ASCLS BOD directors meetings and are permitted to voice their concerns on potential meeting sites through the board of directors. A Recap of the 2022 ASCLS-PA MLT/MLS Student Review

The ASCLS-PA MLT/MLS Student Review is an annual event created and hosted by the Developing Professional chair member. Usually held in early June, this review is held to provide a review of and practice of material seen on the ASCP Board of Certification exam for future medical laboratory technicians and scientists. Most of those who attend this event are current students in an MLT/MLS program or have recently graduated from their program. This review is meant to cover material in six main medical laboratory subjects – chemistry, urinalysis, microbiology, immunology, hematology, and blood bank which are learned during the students' clinical year(s) within their individual medical laboratory programs. This review of information is then used to aid the students in passing their board exams in order to be a licensed practitioner of MLT/MLS.

Due to the ongoing COVID-19 pandemic, this past year's Student Review was not held in-person. Despite this fact, I am proud to say that the review was held virtually on Zoom on June 4, 2022 and boasted 82 registrants ranging from Pennsylvania, Maryland, New Jersey, Delaware, and New York!

The meeting began with a segment of greetings and thank yous to the speakers held by ASCLS-PA's President, Travis Bicher, and myself. Following this was an enlightening question-and-explanation style review of chemistry and urinalysis conducted by Children's Hospital of Philadelphia's Derick Lim, MS Cell Biology and Biotechnology, SC (ASCP), MLS (ASCP). Alan T. Evangelista, Ph.D., D(ABMM), Director of Microbiology and Virology/Molecular Diagnostics at St. Christopher's Hospital for Children, then

held a similar style review of microbiology and virology, covering questions relating to real-world situations seen in a lab for the participating students. We then covered a very interactive review of immunology by Melody Botterbusch, BS General Science, MT, SC(ASCP), Clinical Instructor at Wellspan York Hospital School of MLS, who gave cheerful congratulations to the students for making it through their programs.

After a break for lunch came a thorough hematology review and tips on the importance of analyzing board questions, conducted by Joshua Cannon, MS, MLS(ASCP) CM, MLS Teaching Assistant Professor and Education Coordinator at Thomas Jefferson University. A blood bank review discussing the genetics of blood, antibodies in the blood, and other blood proteins and functions was held by Joy Gould, MS Biochemistry, SBB(ASCP)C, BB, MLT, CQIA(ASQ), CPHQ, also an MLS Teaching Assistant Professor at Thomas Jefferson University Hospital. Dana Staranowski, MLS(ASCP)CM, who works in Special Coagulation at the Hospital of the University of Pennsylvania and was ASCLS-PA's Ascending Professional, closed our Student Review with a collection of test-taking tips and a segment of time to allow the attendees to ask questions on what to expect at the board exam.

It was a long day of reviewing material, but participant feedback indicated it was received positively. Many students appreciated the visuals that portrayed what might be seen in a lab setting when receiving certain results. Question-and-answer segments were also valued by the students — especially if they contained a

thorough explanation of the answer when the students answered incorrectly.

Bylaws

Delegates to the 2022 ASCLS House of Delegates voted on two amendments to the ASCLS Bylaws, Article IV – Board of Directors, Article IX – Regional Councils, and Article X – Society Forums. Bylaws amendments require a 2/3 vote of the credentialed delegates seated for the meeting. The amendment to delete the term "Regional" from Article IV – Board of Directors and to insert "at least" into Article IX.A – Regional Councils was introduced at 10:30 AM and after discussion, the initial vote was conducted at 12:25 PM. As this was a "Hybrid" House of Delegates, meaning that there were delegates seated in person and also on-line, all voting was conducted electronically. There were 191 credentialed delegates and 15 Board members. After the vote was

closed, 122 votes were cast in favor and 41 opposed. Since 135 affirmative votes were needed to adopt the amendment and it appeared that 43 delegates did not cast a vote, a roll call vote was called for. This is the first time in 45 years that such a vote was necessitated. It took over an hour for the roll call where each delegate had to register their vote vocally. This time 163 delegates voted and the results were 127 votes in the affirmative and 36 were opposed. The amendment was adopted.

The second amendment established the Clinical Laboratory Educators Forum which replaced the Educators Scientific Assembly. This amendment was adopted with 157 affirmative votes with only 1 opposed.

Laboratory Legislative Symposium
