As the final leaves fall here in the Delaware Valley, it is a great time to take stock on where ASCLS-PA is moving this year. My involvement in ASCLS-PA is now nearly 30 years, but members are decreasing, and we now have a concern regarding the number of members assisting in our professional endeavors.

The turnover of membership can't continue without significant consequences. At the fall Board meeting the lapsed member list was divided among the leadership and we are reaching out to members to renew their membership. As you look around your place of employment the probability is very high that no more than 5% of laboratory staffs are members of any professional organization.

The value of our educational opportunities, (national, state and chapter), personal services, publications, grass roots activities and governmental affairs easily justify our membership dues. As we call our lapsed members to renew their membership many of them cite the economy. ASCLS membership is less than \$2 per week! If you are feeling financial stress what better way to network with others outside your place of employment...which may lead to better opportunities in the future!

ASCLS-PA had a very successful fall Board Meeting and a one-day education meeting in State College

this September. This followed a successful meeting in Wilkes-Barre, fall 2010, and a state meeting in Harrisburg in the spring of 2011.

The format of a one day meeting holds a great deal of promise in reaching areas where ASCLS does not have a large concentration of members. If you are interested in a one day education meeting in your area contact your local state board member. Although the one day meeting is "less work" than a large multi room/day meeting, we still need volunteers to help plan and organize all these meetings.

Meanwhile we continue to plan for a State Meeting on the campus of the University of the Sciences in Philadelphia on Monday, May 7th and Tuesday, May 8th. Our state organization is strong. Unfortunately, six of our state chapters are inactive. The two current active chapters in Pennsylvania are the Northwest (Erie) and Delaware Valley (Philadelphia). Organizing and restarting a chapter requires 2-3 people who are dedicated to holding educational meetings, promoting the laboratory profession in your geographic area and recruiting their colleagues to help.

It is a great way to network and learn what the other institutions in your area are doing to meet the SAME challenges that you meet every day. Do not be surprised if you receive a call from me to ask you to organize your chapter!

Are you ever asked what the benefits of volunteering may be? The contacts that you make will always benefit you in your professional life. I was a post box member and not involved in the society until 1987 when I went to hear Mary Ann McLane (now a former President of ASCLS) who was my instructor in clinical chemistry in 1982 give a local chapter presentation on the measuring and difference between Precision and Specificity. Within a few months I was working on the state meeting and have never looked back. ASCLS has always given individuals the opportunity to lead with a built-in mentoring network.

I probably wouldn't have volunteered to be President of ASCLS-PA if I had known we would be building a new laboratory at work, but then I know that I can count on all of you for help to get through this year. Free Online Educational Opportunity

Dear Colleagues:

We are pleased to announce that the Centers for Disease Control and Prevention (CDC), Division of Laboratory Science and Standards is now offering a free online laboratory training module entitled "READY? SET? TEST! Patient Testing is Important. Get the right results."

This training was developed to supplement other free educational materials already available from CDC to promote good laboratory practices and assure the quality of patient testing, especially in physician office laboratories and other sites that perform testing waived under the Clinical Laboratory Improvement Amendments of 1988 (CLIA). It includes practice exercises, job aids, and real-life testing scenarios to reinforce the learning process.

After completing the module, participants may print out a Certificate of Completion and obtain continuing education credits offered to physicians, nurses, pharmacists, laboratory professionals, and others.

We encourage you to share this information broadly with colleagues who are concerned with promoting good laboratory practices, especially in waived testing sites. In addition, if possible, we would appreciate your organization or facility's inclusion of an electronic link to the training and other educational materials at the following CDC website locations.

Responding to the listserv

If somebody sends a message out to the membership using the listserv, you have two options for responding:

1.) Reply to the entire membership- simply hit "reply." You do not have to hit "reply all" to send to the entire group. **NOTE:** the message will tell you that "Joe" sent it, but hitting "reply" will still send your response to the entire group.

2.) Reply to just Joe- hit "forward." Then copy and paste Joe's email in the "to" box and send your response.

In Memoriam of Henry (Hank) Kormanski

In Memoriam

It is with regret that we inform the ASCLS-PA membership of the death of Henry (Hank) Kormanski in Hawaii, March 29, 2011. Hank worked with for the Dolbey company, Upper Darby, PA as an office manager for many years.

Who was the Dolbey Company? They were a Philadelphia based pharmaceutical, medical and lab supply wholesale company. In "olden times," they were the company that saved our lives many times with a bulb for the spectrophotometer, some antigens needed for a test, when our supply was depleted. Hank often answered the phone, and could tell what size test tube you needed for a test. Also, they repaired equipment, microscopes, and in case of an emergency, they would send someone out to help repair your equipment.

Hank was blind, and Mr. Edward Dolbey had polio as a child. Both worked, attended concerts, and traveled the country together. Mr. Dolbey started the "MT of the year" award to honor outstanding MT's many years

ago. It was presented at the Spring PSMT meeting. After Mr. Dolbey became unable to attend the meetings in person, Hank would come and present the award.

Hank graduated from the University of Pennsylvania, spoke several languages, and was very witty! Hank's blindness never stopped him from accomplishing many things. Mr. Dolbey and Hank moved to Hawaii where they enjoyed the warm climate and the islands. It was not unusual to see Hank pushing a wheel chair, with Mr. Dolbey riding and giving directions. Mr. Dolbey died several years ago, and Hank moved to an Assisted Living Facility, still enjoying Hawaii to his end.

"His gracious character, and enjoyment of life, was an inspiration to those who were his friends. We all loved you Hank, and you will never be forgotten."

Successful CE Event in State College

In keeping with ASCLS-PA's strategic initiative to broaden our reach to Central and Western PA, ASCLS-PA and PSSAMT sponsored a CE event in State College on September 12. After a warm reception in DuBois, PA in 2010 with an afternoon CE event we decided to have a full day of CE in State College.

The State College meeting was very successful with 6 speakers and 65 attendees. We also had 5 vendors onsite, including a Siemens trailer. The presentations covered all major disciplines in clinical laboratory science that could be applied to the BOC Certification Maintenance Program. Additionally, a 1 credit vendor CE quiz was available for attendees.

The State College meeting showed significant growth from the 2 speakers and 20 attendees in DuBois last year. There was much enthusiasm for the continuation of CE events in Central PA and we hope to continue providing such networking and CE opportunities in Central PA.

We have also had many requests for providing a student review session in this region. If the support continues, we would very much like to offer such an opportunity for a student review.

For student review sessions, we could really use some help and insight from students. Many opportunities are available for motivated MLS/MLT students that want to be involved in developing our profession.

New ASCLS Certification Maintenance Membership

As most of you are now aware, all MT (MLS) and MLT students graduating after 2004 are required to complete 36 hours of CE every three years to keep their ASCP BOC certification. ASCLS now has a special membership for individuals who are either required to maintain their certification or for those that wish to voluntarily maintain their certification designated as MLS^{cm} or MLT(ASCP)^{cm}.

With an ASCLS membership, you get 12 online CE credits per year for \$55 through LabCE.com. This discounted price through LabCE.com is only available to ASCLS members. The 12 credits will cover all disciplines that are required by the ASCP BOC. After 3 years the required 36 credits will have been obtained for certification maintenance.

As all of the courses are offered online, this is a great option for those who are unable to attend enough educational events throughout the year to meet the necessary CE requirements. And ASCLS's online CE organizer makes keeping track of your transcripts easy.
