## The ASCLS-PA Student Review Session was a Success!

The Student Review Session was reinstated this year at the 2010 ASCLS-PA Annual Spring Meeting in King of Prussia, PA. On May 11, approximately 60 students came to the review session in preparation for the Board of Registry certification examination which tests the core subjects of chemistry, hematology, microbiology, and blood bank.

The day kicked off with Katey Howell, the First Year Professional of ASCLS-PA, who gave a talk on both the American Society for Clinical Laboratory Science and on Test Taking Tips for the Registry. The remainder of the review sessions focused on the subjects contained in the examination. Medical Technologists and professors from several different hospitals came to present students with ideas on what is the most important information to focus on when studying for the

exam. Blood Bank was presented by Barbara Steiber from York Hospital; Hematology and Coagulation by Dr. Raelene Maser of the University of Delaware; Chemistry and Urinalysis by Dr. Mary Ann McLane (our ASCLS president) of the University of Delaware; Microbiology and Immunology by Wendy George of Lancaster General Hospital; and Laboratory Management and Safety by William Hunt of the University of Pennsylvania.

The sessions were very successful and after talking with a number of students, nearly everyone seemed pleased with the quality and enthusiasm that the speakers brought to the sessions. I'd like to thank all of the speakers, the ASCLS-PA board members, and especially the students for making the day a great success!

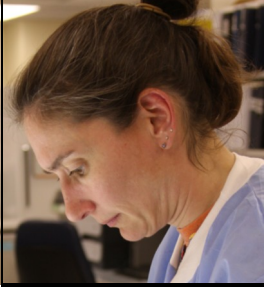

1.) Reply to the entire membership- simply hit "reply." You do not have to hit "reply all" to send to the entire group. **NOTE:** the message will tell you that "Joe" sent it, but hitting "reply" will still send your response to the entire group.

2.) Reply to just Joe- hit "forward." Then copy and paste Joe's email in the "to" box and send your response.

# 2010 ASCLS-PA Spring Meeting Wrap-Up

The Annual Spring Meeting for Clinical Laboratorians in Pennsylvania and surrounding region was held at the Radisson Valley Forge Scanticon Hotel on May 11<sup>th</sup> and 12<sup>th</sup>, 2010. This premier event was hosted by the American Society for Clinical Laboratory Science (ASCLS-PA) and the Pennsylvania State Society of American Medical Technologists (PSSAMT). Each group conducted governance meetings during the meeting.

An overview of the Board of Certification and what it means for Medical Laboratory Scientists now and in the future served as a plenary session on Tuesday afternoon. Forty-five discipline-specific lectures and 6 review sessions designed for clinical laboratory students were presented during the two day meeting. Each day provided the opportunity to obtain 6 hours of continuing education, plus 1 contact hour available for completion of a vendor exhibit quiz.

Over 250 laboratorians, including more than 50 students attended the two-day meeting. The student review sessions were organized by Laurie Flood the ASCLS-PA Student representative. Katey Howell the ASCLS-PA New Professional representative welcomed students to the profession and spoke about test taking tips when preparing for certification examinations. The 6 review sessions were attended by students, educators, and bench technologists and received great evaluations.

Evaluations of other sessions noted speakers who were passionate about clinical laboratory science, provided excellent handouts, were outstanding presenter, gave highly detailed information, and provided a vision of clinical laboratory testing in the future. Experts from all areas of the United States shared their knowledge during this meeting.

We owe a special thanks to our industry partners who sponsored speakers. They are: AACC-Philadelphia, Roche Diagnostics Corporation, Beckman-Coulter, Quest Diagnostics, Miller-Keystone Blood Center, Ortho-Clinical Diagnostics, Gen-Probe, Inc., BD Diagnostics, BD GeneOhm, Meridian Biosciences, Siemens Healthcare Diagnostics, Abbott Diagnostics, Radiometer America, Trinity Biotech, ARUP Laboratories, AABB, and Bio-Rad Laboratories.

The vendor show was a highlight of the meeting with more than 14 companies exhibiting their equipment and services. In addition, Ortho-Clinical Diagnostics brought their Adventour mobile laboratory to demonstrate their "instrumentation in action" for conference attendees. The attendees who received PACE credit for participating in the vendor exhibit quiz rated their interactions with exhibitors highly. We sincerely appreciate all the support we received from our industry partners. A modest profit of \$3000 was realized because of their support. [Note: Registration fees for students do not cover the cost of their attendance at the meeting.]

A deep debt of gratitude is owed to our program chair William Hunt, our registrar Sharon Strauss, PACE coordinator Sandy Toloczko, vendor liaison Charles Wilson, and other committee members and moderators including Dee Dolan, Ruth Negley, Katie Franz, Michele E.
