# Reflections from the 2004 annual meeting

At the 2004 annual meeting of the American Society for Clinical Laboratory Science, I found myself wearing many "hats". Now, for those of you who know me, you will recognize that this is not



an unusual situation! What I experienced this time, however, was something that brought with it a mantra, and the mantra is "Provide the Face". Allow me to explain. As the Region II Director, I am a member of the Board of Directors of our society. In that capacity, I attended the 3 board meetings on site and hopefully provided the face of our wonderful region (which includes Pennsylvania, Delaware, New Jersey, Maryland, Virginia, West Virginia and the District of Columbia) to the rest of the ASCLS board. I also was the board liaison this past year for the CLS journal, the consumer webpage team, the Committee on Professional Affairs, and thus needed to provide the face for their concerns as well to the board. I was asked to serve on a task force to compose a position paper on Direct Access Testing, so I needed to provide the face of that team and our final document to the delegates who were going to be voting on that paper at the House. I belong to the ASCLS consumer webpage response team which provides answers to people's questions about the meaning of their lab test results, and we learned at this meeting that since 1999, we have provided such answers to over 10,000 people... providing the face of clinical lab professionals, oneon-one, to the general public, BIG TIME! It has probably been that last experience which, more than any, has convinced me that we each need to try, in our own way, to PROVIDE THE FACE to the general public concerning the critical nature of lab testing for the diagnosis and treatment decisions of clinicians, and the equally critical role of the lab professionals who design, perform and maintain the quality of those tests. I have told the presidential officers in each society within our region that I want 2004-2005 to have as its theme, "PROVIDE THE FACE". I invite you to become involved in these efforts. I promise you that you will have no greater affirmation of your training and professionalism than to interact with your colleagues and the general public in sharing that information.

Each state is working on its own plan for implementing this theme, including volunteering to speak at your local Kiwanis, Lions Club, AARP groups, as well as making local visits to your state legislators (who, by the way, are making decisions about your profession with minimal input from clinical lab professionals!). The meeting was called to order by President Snyderman at 0930. She thanked all present for sacrificing a summer Saturday to take care of society business. She also expressed appreciation to Secretary Sandra Neiman, who was unable to attend, for making arrangements for meeting space.

**Agenda:** Reports of the chair of the 2004 Student Review Session and Web Master were added to the agenda.


