News Hot Off the Press From ASCLS

During the past year the ASCLS Professional Doctorate Task force was engaged in the implementation of the terminal doctorate in CLS. During this same timeframe, the National Accrediting Agency for Clinical Laboratory Science, (NAACLS) worked on a similar project. The NAACLS Graduate Task Force (GTF) was charged with determining the feasibility of an advanced practice doctoral degree in the field of clinical laboratory science. The GTF was also to consider whether or not NAACLS should develop standards for such an academic program. At this time the GTF have developed a draft document, "Standards of Accredited Educational Programs for the Clinical Doctorate in Clinical Laboratory Sciences." This document is available on the NAACLS website, <http://www.naacls.org/> under Announcements, Requests for Comments - CLS Doctorate. NAACLS invites comments, suggestions, questions or critique of the draft standards. This is an opportunity for you to have input into the future direction of the profession of Clinical Laboratory Science We encourage you to look at this document and send your comments and suggestions, to NAACLS by Sept 30. Please share this information with your members. Thank you.

Success for Review Participants!

The ASCLS-PA student review session was held on Saturday, June 3rd at the Harrisburg campus of HACC in Harrisburg, PA. Due to the generosity and enthusiasm of both the speakers and the registrants, the review was a huge success. Forty students from six different states participated in the review, which covered the major subjects of chemistry/urinalysis; hematology/coagulation; immunology/immunohematology; and microbiology.

The day began with two dynamic speakers from the University of Delaware. Through their presentations, participants received a taste of BOR question and answer formats. Both speakers encouraged students to contact them via email or to visit specific web site addresses to further their learning experiences. Then, after a fulfilling lunch sponsored by Quest Diagnostics, the afternoon began with a microbiology speaker from Hershey Medical Center and a laboratory inspector from the PA Department of Health. The review ended with a short session given by the ASCLS-PA president and a handy demonstration on how to apply and prepare for the exams. Participants were given PACE credits for each of the sessions attended, and not one person was seen leaving early. After the review students spent time interacting with speakers and commenting on what had just been experienced. It was truly an informative and educational day for all involved.
